

# PRIVACY AND COOKIES POLICY

## INTRODUCTION

This Privacy and Cookies Policy applies between you, the User of this Website and Signscape and Signconex Limited, the owner and provider of this Website. Signscape and Signconex Limited takes the privacy of your information very seriously. This Privacy and Cookies Policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

## DEFINITIONS AND INTERPRETATION

In this Privacy and Cookies Policy, the following definitions are used:

<b>Data</b>	collectively all information that you submit to Signscape and Signconex Limited via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
<b>Cookies</b>	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
<b>Data Protection Laws</b>	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
<b>GDPR</b>	the General Data Protection Regulation (EU) 2016/679;
<b>Signscape and Signconex Limited, we or us</b>	Signscape and Signconex Limited, a company incorporated in England and Wales with registered number 5763360 whose registered office is at Pear Tree Industrial Estate, Bath Road, Upper Langford, Bristol, BS40 5DJ;
<b>UK and EU Cookie Law</b>	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
<b>User or you</b>	any third party that accesses the Website and is not either (i) employed by Signscape and Signconex Limited and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Signscape and Signconex Limited and accessing the Website in connection with the provision of such services; and
<b>Website</b>	the website that you are currently using, <a href="http://www.sasl.co.uk">www.sasl.co.uk</a> , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

In this Privacy and Cookies Policy, unless the context requires a different interpretation:

- the singular includes the plural and vice versa;
- references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy and Cookies Policy;
- a reference to a person includes firms, companies, government entities, trusts and partnerships;
- "including" is understood to mean "including without limitation";
- reference to any statutory provision includes any modification or amendment of it;
- the headings and sub-headings do not form part of this Privacy and Cookies Policy.

## **SCOPE OF THIS PRIVACY AND COOKIES POLICY**

This Privacy and Cookies Policy applies only to the actions of Signscape and Signconex Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

For purposes of the applicable Data Protection Laws, Signscape and Signconex Limited is the “data controller”. This means that Signscape and Signconex Limited determines the purposes for which, and the manner in which, your Data is processed.

## **DATA COLLECTED**

We only collect the information that’s necessary to carry out our business, provide the particular product or service you’ve requested and to keep you informed.

We may collect the following Data, which includes personal Data, from you:

- name;
- contact Information such as email addresses, telephone numbers and home/work addresses;
- IP address (automatically collected);
- web browser type and version (automatically collected);
- operating system (automatically collected);
- a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected);

in each case, in accordance with this Privacy and Cookies Policy.

## **HOW WE COLLECT DATA**

We collect Data in the following ways:

- data is given to us by you ;
- data is received from other sources; and
- data is collected automatically.

## **DATA THAT IS GIVEN TO US BY YOU**

Signscape and Signconex Limited will collect your Data in a number of ways, for example:

- when you contact us through the Website, by telephone, post, e-mail or through any other means;
- when you register with us and set up an account to receive our products/services;
- when you complete surveys that we use for research purposes (although you are not obliged to respond to them);
- when you enter a competition or promotion through a social media channel;
- when you make payments to us, through this Website or otherwise;
- when you elect to receive marketing communications from us;

## **DATA THAT IS COLLECTED AUTOMATICALLY**

This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
- we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

## **OUR USE OF DATA**

Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

- internal record keeping;
- improvement of our products / services;
- transmission by email of marketing materials that may be of interest to you;

in each case, in accordance with this Privacy and Cookies Policy.

We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:

- soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.
- for other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.
- if you are not satisfied about our approach to marketing, you have the right to withdraw consent at any time. To find out how to withdraw your consent, see the section headed "Your rights" below.

## **KEEPING DATA SECURE**

We will use technical and organisational measures to safeguard your Data, for example:

## DATA RETENTION

- **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
- **Right to erase** - the right to request that we delete or remove your Data from our systems.
- **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
- **Right to data portability** - the right to request that we move, copy or transfer your Data.
- **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
